CONDITIONS OF USE FOR TENNIS COURT
SEASON TICKET HOLDERS

1. Season Tickets are available to all residents of Winkfield Parish upon payment of the relevant fee.
2. Season Tickets will be available to residents of other parishes at the discretion of the Council.
3. There are 4 types of Season Ticket available:

Family (up to 2 adults and 4 children)
Adult (over 18)
Junior (12 – 17 years)
Child (5 – 11 years)
4. Season Ticket holders under 14 should be supervised by a responsible person.
5. A Season Ticket allows the holder use of the courts from the valid date until 31st December of the same year (subject to availability).
6. Coaching is permitted as long as both parties are Season Ticket holders. Any persons found to be using the courts for coaching where both parties are not Season Ticket holders will have the Season Ticket withdrawn. Any coaching may be requested to cease if it is causing a distraction to other players.
7. Season Tickets are for personal use only.
8. An Adult Season Ticket Holder is allowed to bring one guest, either an Adult or Junior on 3 occasions per year. A Junior or Child ticket holder is not allowed to bring any guests.
9. Up to 4 people may play on a court at any one time.
10. Season Ticket holders may book a court by completing the booking form situated on the noticeboard inside the courts.
11. There will be 2 “open member” sessions per week for which booking is not required – Tuesday 9am – 12noon and Saturday 1pm – 5pm. Courts should be booked at all other times.
12. Season Ticket holders may only book one court at any one time for a maximum of 1 hour. All bookings are subject to fair usage and the Council may revoke the Season Ticket of anyone considered to be abusing the booking system.
13. Season Ticket holders may use the courts without having made a prior booking providing a court is available. However, it is advisable to book a court in advance.
14. Season Tickets should be carried at all times when using the courts as spot checks are carried out regularly. Anyone unable to produce their ticket will be asked to **VACATE THE COURTS IMMEDIATELY**.
15. Suitable sportswear should be worn at all times. Always wear soft sole tennis shoes. Non-marking shoes must be worn - if shoes are marking the surface you will be asked to leave the court
16. Adult/Family Season Ticket Holders will have use of the toilet to the side of the Pavilion.
17. Fees for Season Tickets will be reviewed annually and will become due in January each year.
18. Unsportsmanlike or noisy behaviour will not be tolerated. Any infringements of this rule will result in the player concerned being asked to leave the court.
19. The court surface may soften during hot weather. If this happens play must be stopped immediately and the Council informed.
20. Do not place heavy objects (eg benches) on the surface. **Sharp toys, roller skates, bicycles, etc are not permitted on the court surface.**
21. All litter must be removed from the court and placed in the litter bin.
22. After play the net must be lowered to a half-way point to release the tension.
23. When you leave the courts, ensure the gate is **closed and locked**. Never lean on, or attempt to jump the net.
24. Please check the toilet door is closed after use.
25. No animals are allowed on the courts at any time.
